**Re:** **Approval of Accident-Related Repairs to Light Poles and Pedestrian Signal Equipment**

**Background:**

On 11/16/25, a light pole at the Keystone Road and Cass Road roundabout was struck, knocking down the pole and damaging the light, pole, and foundation. On 11/20/25, a separate incident occurred at the Keystone Road and River Road roundabout, resulting in similar damage to a light pole, including the light, pole, and foundation. On 11/25/25, an accident at the S. Airport Road and Veterans Drive intersection caused damage to signal equipment on the northwest corner, including the pedestrian push button, its foundation, the buried conduit, and the strain pole.

Electrical work is a specialty item that does not require competitive bidding. Because Windemuller previously installed the light poles at these roundabouts, they were contacted to provide quotes for the repair work. Repairs at the roundabouts will include removal and disposal of the damaged foundations; installation of new light pole foundations; restoration of conduit and electrical connections; and installation of new light poles and fixtures. The quoted cost for each light pole replacement is \$18,079.00.

Repairs at the S. Airport Road and Veterans Drive intersection will include resetting the dislodged pedestrian push button foundation, repairing the buried electrical conduit, and reconnecting the wiring to the push button, for a quoted cost of \$1,600.00.

**Recommendation:**

Staff recommends approving Windemuller to perform accident-related repairs for a light pole at the Keystone Road and Cass Road roundabout, a light pole at the Keystone Road and River Road roundabout, and the pedestrian push button foundation at the S. Airport Road and Veterans Drive intersection, in the total amount of \$37,758.00.
