## **GRAND TRAVERSE COUNTY ROAD COMMISSION TEMPORARY TRAFFIC CONTROL ORDER**

In accordance to Section 257.606, 257.610 and 257.611 of the Michigan Vehicle Code, the Grand Traverse County Road Commission is placing:

In the County of Grand Traverse, East Bay Township:

A temporary NO PARKING zone on the north and south side of E. Hammond Road between Haaland Rd and Rasho Road and on the west side of Haaland Rd and Six Mile Road from Pamala Lane to Dogwood Drive and the north and west side of Whispering Oaks and north side of Dogwood Drive and the east and west sides of Fielstra Dr. and both sides of Averills Circle. All No Parking signs shall be erected and maintained by Iceman Promotions, Inc.

Parking is prohibited on Friday, November 1, 2019 from 12:00 PM to 8:00 PM, and Saturday, November 2, 2019, from 6:00 a.m. to 8:00 p.m.
